#### 1 CHAIR'S OPENING REMARKS

The Chair opened the meeting by welcoming members, and giving a review of the year's activities.. (Full Chairman's Report as attached document)

## 2. MINUTES of the AGM held on 6th November 2017

Matters Arising -

#### 3. CHAIRMAN'S REPORT

The Chairman's report summarised the Society's actions and achievements over the previous 12 months, full report at the end of the minutes.

#### 4. SECRETARY'S REPORT

We continue to follow the WAG website, CCBC, TBC, and other news sources to keep an eye on anything that affects us, and other areas with similar landscapes.

We are researching ideas for landscape management and development similar to what was discussed with the authors of the Scoping Study in 2013.

The society has been kept informed of developments by CCBC of major new funding jointly administered with Torfaen BC that has been incorporated into the 'Adventure Triangle' Scheme. CTS is included as an interested Volunteer Group, with the Commoners, and Blaen Bran and have participated in meetings to establish projects where the funding can be applied.

Subsequent 'Cabinet Papers' have rejected or cancelled some schemes, and others have already been implemented, such as the Adventure Play Equipment installed above the Lake in Cwmcarn.

# 5. TREASURER and MEMBERSHIP SECRETARY'S REPORT

A balance sheet was circulated,

#### 8. A.O.B. POLICING

PC Simon James explained the current policing situation regarding illegal off roading and Anti-social behaviour.

The area has been relatively quiet for the Summer, but recently there has been a lot of activity in all the areas I cover. Fly tipping has reduced on Twmbarlwm, but increased in other CCBC sites.

There should be better provision for legal bike riding, such as Howard Duke's track, which can be fenced and policed to avoid 'escapees' on to the mountain.

The problems are not just Torfaen, BG or Caerphilly, but nationwide, and will need a wide ranging solution, lack of resources constrains action in a lot of areas.

#### **TIDY TWMP**

Les Murphy recounted his recent trip to Ireland to see the results of the Hen Harrier Project, we will be continuing to discuss this with the Trustees in the coming months.

#### 9. CHAIR'S CLOSING REMARKS

The Chair thanked members for attending. He emphasised again that the work of the Society was far from complete, and he encouraged our newly elected Trustees to take us into the New Year with the expectation of several new projects for us to embrace.
